Subject of the Disclosure

The Sangilo mine owned by Itogon-Suyoc Resources, Inc. (ISRI), (a 100%-owned subsidiary of Apex Mining Co., Inc.), located in the Municipality of Itogon, Benguet Province, is included in the localized lockdown order issued by the Punong Barangay of Barangay of Poblacion dated 23 October 2020 due to COVID-19 positive cases reported.

Background/Description of the Disclosure

This is to inform the Exchange that the Sangilo mine owned by Itogon-Suyoc Resources, Inc. (ISRI), (a 100%-owned subsidiary of Apex Mining Co., Inc.), located in the Municipality of Itogon, Benguet Province, is included in the localized lockdown order issued by the Punong Barangay of Barangay of Poblacion dated 23 October 2020.

As of 26 October, more than eighty COVID-19 positive cases have been recorded in the mine site. Management is still awaiting all results of the swab tests conducted by the Rural Health Unit (RHU).

ISRI has doubled up on its mitigation measures, disinfecting all the areas where the COVID cases were identified. The Company's containment facility is also ready to accommodate patients. Management is also seeking assistance from the LGU to conduct mass testing among its employees in the mine site.

Operation will resume upon completion of contact tracing and swab testing, and only those with negative results will be allowed to return to work.

As of this disclosure, the potential impact of these COVID-related developments to ISRI's operations and financial results are still undetermined. We will advise you of any development regarding this matter.

Meanwhile, Apex Mining's Maco mine in Davao De Oro remains operational and COVID-19 free, where health and safety protocols continue to be strictly implemented.
