

**Subject of the Disclosure**

Apex Receives Notice of Violation and Cease and Desist Order for its Mineral and Production Sharing Agreement (MPSA) No. 234-2007-XI in Davao De Oro

**Background/Description of the Disclosure**

The Company received today a Notice of Violation from the Environmental Management Bureau XI and Cease and Desist Order from the Mines and Geosciences Bureau XI for its MPSA No. 234-2007-XI, which is currently under Exploration Period, in relation to the landslide that occurred within the area on March 15, 2023 that affected the old Tailings Storage Facility previously utilized between 1976 to 1989.

On March 8, 2023, a very strong earthquake with a magnitude of 5.9 was felt and a series of light to moderate aftershocks were registered in Davao de Oro.

The Maco mine continues to operate under its MPSA 225-2005-XI which is the source of its current production output.

The Company will undertake the necessary steps to comply with the recommended actions to address the issue and comply with the requirements of the Notice of Violation and Cease and Desist Order.
